Approved a grant to the NUSA Center for Energy and Environment Technology (a Vietnam-based non-profit) of \$25,000 to construct clean water filtration systems for five communities in the Ha Tinh and Quang Binh provinces. This project will supply clean drinking water for approximately 14,000 school children and poor villagers. The project is being co-funded with the local authorities and the Viet Nam Women's Union. The grant was approved on 15 August 2014 and was completed on 25 November 2014.

**4b** (Code: ) (Expenses \$ 9,500 including grants of \$ 9,000 ) (Revenue \$ 0 )

Approved a grant to Center for Community Health Research and Development (a Vietnam-based nonprofit) of \$9,000 to revise and publish 1,200 copies of the photo book titled "Finding Ourselves" in support of the Lesbian, Gay, Bisexual and Transgender community its health promotion effort in Viet Nam. The project was approved on 21 June 2014 and was completed on 12 December 2014.

Approved a grant totaling \$310,651 to Training for Health Equity Network (a US-based 501(c)(3) non-profit) over 18 months beginning 1st August 2014 to strengthen the evidence base on the effectiveness of the principles and strategies of community-engaged, equity-oriented socially accountable health professional education. The grant was approved on 1 August 2014 and the disbursement amount for 2014 was \$150,000 of the total. The amount payable for 2015 is \$160,651.

Form 990, Part III, Line 2 - Having been established in June 2013 and received its 501(c)(3) status in November 2013, the organization started its programming in earnest during 2014. Its programming activities include: (1) started its registration application for its office in Ha Noi, Viet Nam; (2) approved grants in improving access to clean water for several communities in Viet Nam; (3) approved a grant to assist the gay community with its health education programming; (4) approved a grant to help improve capacity of the Training for Health Equity Network; and (5) managed population health projects portfolio for The Atlantic Philanthropies to improve health equity in Viet Nam.

Form 990, Part VI, Section A, Line 2 - Ms. Uyen Khue Le is the organization's part-time CFO-Secretary and she is the half-sister of Mr. Phuong Nhan Le, who is the CEO of the organization. This is a temporary arrangement as the organization is newly established and has not been able to hire a full complement of needed staff. Hopefully, we will be able to find suitable long-term staff for these positions in 2015.

Form 990, Part VI, Section A, Line 9 - The organization's mailing address is in Santa Monica, California. All three directors are living and working outside of California: (1) Dr. Mary McDonnell (One Pierrepont Plaza, 15th Floor, Brooklyn, NY 11201); (2) Mr. Tony Proscio (71 Cranberry Street, No. 3, Brooklyn, New York 11201); and Dr. Phuong N. Le (1236 Fork Creek Trail, Decatur, GA 30033).

Form 990, Part VI, Section B, Line 11b - The 990 form will be completed by Dr. Phuong Nhan Le, the CEO and Director, and will be sent to the two other directors (Dr. Mary McDonnell and Mr. Tony Proscio) and the organization's Secretary-CFO, Ms. Uyen Khue Le, for their comments and inputs before the formal filing to the IRS.

Form 990, Part VI, Section B, Line 12c - The potential for conflict of interest is brought up as part of every Board of Directors' meeting. The grantees and potential grantees are reviewed in terms of possible conflict of interest with each director as well as with any staff. Annual statement disclosing possible or on-going conflict of interest is signed by each director and staff of the organization and maintained on file by the organization. The organization's Conflict-of-Interest policy is being revised by a subcommittee in 2015.

Form 990, Part VI, Section B, Line 15 - The salary for the CEO position was determined in December 2013 by looking at the best practice level of the industry and the size of the organization, balancing it with the necessity of living expenses. The report was presented to the Board of Directors for their approval. The decision was made at the level of \$72,000 per year for a full-time CEO position. Likewise, a similar process was carried out for the Secretary-Treasurer position and the decision was made at the \$18,000 per year level, which reflects the part-time nature of the position.
