The mission of Resources for Health Equity, Inc. is to improve access to health care for marginalized populations in Southeast Asia through providing necessary resources to support community-based health organizations, improving the primary health care systems in selected areas, and establishing health equity monitoring systems within the health care network.

Approved a grant totaling \$310,651 to Training for Health Equity Network (a US-based 501(c)(3) non-profit) over 18 months beginning 1st August 2014 to strengthen the evidence base on the effectiveness of the principles and strategies of community-engaged, equity-oriented socially accountable health professional education. The grant was approved on 1 August 2014 and the disbursement amount for 2014 was \$150,000. The amount disbursed for 2015 was \$160,651.

4b (Code:) (Expenses \$ 98,570 including grants of \$ 0) (Revenue \$ 259,018)

Managed the Population Health Programme portfolio of grants in Viet Nam to bring them to a successful conclusion and help to realize the Programme's potential to inspire philanthropy, to win support for investment in public health and education, and to improve policy and practice in Viet Nam, Southeast Asia, and elsewhere.

4c (Code:) (Expenses \$ 50,600 including grants of \$ 49,600) (Revenue \$ 0)

Approved an equipment grant totaling \$49,600 to the Women's and Children's Hospital in Da Nang, Viet Nam. The grant was paid directly to the manufacturer to supply the Hospital with neonatal equipment for the care of sick neonates to address the training and clinical needs of healthcare facilities in central Viet Nam. The grant was approved on 17th December 2014 and the equipment was delivered in full in June 2016.

Form 990, Part VI, Section B, Line 15 - The salary for the CEO position was determined in December 2013 by looking at the best practice level of the industry and the size of the organization, balancing it with the necessity of living expenses part-time in Viet Nam and in the US. The report was presented to the Board of Directors for their approval (Dr. Phuong Le abstained from voting on this). The decision was made at the level of \$72,000 per year for a full-time CEO position. Likewise, a similar process was carried out for the Secretary-Treasurer position and the decision was made at the \$17,500 per year level, which reflects the part-time nature of the workload.

Form 990, Part VI, Section C, Line 19 - The organization just recently established its website at www.resourcesforhealthequity.org and is in the process of putting all of its governing documents as well as financial statements and completed 990 forms for 2013 to the present.
